The primary objective of this analysis is to evaluate the effectiveness of the existing syllabus,

identify strengths and areas for improvement, and ensure alignment with contemporary

academic standards and industry expectations.

• Student feedback reflects a high level of satisfaction with the curriculum's structure, content

depth, practical applicability, and relevance to academic and career development.

• Alumni responses reinforce the curriculum's value, particularly its contribution to skill

development, employability, and long-term academic foundations.

• Faculty feedback emphasizes the syllabus's academic coherence, incorporation of recent

trends, and its encouragement of innovation, critical thinking, and interdisciplinary learning.

Overall, the collective responses from these three groups indicate that the syllabus is well-

received and largely effective. The data-driven insights derived from this feedback serve as a

foundation for continuous curriculum enhancement and quality assurance in teaching and

learning.

The feedback collected from students regarding the syllabus has shown a strong level of

satisfaction across multiple key dimensions of curriculum design and delivery. Below is a

summary of the major insights derived from the analysis:

### 1. Relevance and Learning Needs:

### 5. Experiential Learning Opportunities:

While feedback was generally positive, students indicated that there is scope for more practical exposure, such as internships, fieldwork, lab work, and applied learning experiences.

### 6. Theoretical Depth:

The majority of students rated the syllabus highly in terms of academic rigor and depth of theoretical content, reflecting a strong foundation in core concepts.

### 7. Critical Thinking and Problem Solving:

The syllabus was seen as successful in fostering independent thinking, logical reasoning, and analytical ability among students.

#### 8. Ethical and Value-Based Education:

Students appreciated the inclusion of moral and ethical learning where applicable. This component adds value to holistic education and character formation.

#### 9. Overall Satisfaction:











Most alumni recognized the academic rigor and conceptual depth of the syllabus, indicating

strong preparation for postgraduate education and professional certifications.

**Critical Thinking and Problem-Solving:** 

The curriculum was seen as effective in nurturing analytical abilities and independent

thinking—skills they found applicable in real-life contexts.


### **Overall Satisfaction:**

With nearly 88% alumni expressing satisfaction, the syllabus was viewed positively for its educational and professional contribution.










### **Pie Chart Analysis – Introduction**



By using pie charts, the institution can more effectively recognize the strengths of the current syllabus as well as areas that may require enhancement or revision.




2 The syllabus is well-structured and logically sequenced.



3 The syllabus reflects current trends and recent developments in the subject area.






